8 SYNOPSIS: This bill makes appropriations for the
9 support, maintenance and development of public
10 education in Alabama, for debt service, and for
11 capital outlay for the fiscal year ending September
12 30, 2011.

15 TO BE ENTITLED
16 AN ACT

18 To make appropriations for the support, maintenance
19 and development of public education in Alabama, for debt
20 service, and for capital outlay for the fiscal year ending
21 September 30, 2011.

22 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

23 Section 1. There is hereby appropriated for the
24 support of public education in Alabama for the fiscal year
25 ending September 30, 2011, for debt service, and for capital
26 outlay to be paid out of funds specified in subsection (a) of
27 Section 2 of this act, the amounts specified in subsections

1 (a), (b), (c), and (d) of Section 3 and Sections 4, 5, 12, 15
2 and 16 of this act. For the purpose specified in subsection
3 (b) of Section 2 of this act, amounts are shown by
4 programmatic area and the total for all programs is shown so
5 as to include estimated sources of funds other than those
6 listed in subsection (a) of Section 2 of this act. For the
7 purpose of this act, "ETF" shall mean the Education Trust Fund
8 and "Federal and Local Funds" shall mean all gifts, grants,
9 contributions, or entitlements, including grants by the
10 Congress of the United States, municipalities or counties.

11 Section 2. (a) The appropriations provided for in
12 this act shall be paid from funds in the State Treasury to the
13 credit of the Education Trust Fund, Alabama Peace Officers'
14 Standards and Training Fund, Impaired Drivers Trust Fund,
15 Driver Education and Training Fund, Special Education
16 Catastrophic Fund, Alabama Veterans Assistance Fund, and
17 Public School Fund and are hereby made for the support of
18 public education in Alabama for the fiscal year ending
19 September 30, 2011, and the appropriations herein made shall
20 be subject to the provisions, terms, conditions and
21 limitations of the Budget and Financial Control Act (Code of
22 Alabama 1975, Sections 41-4-80 et seq.), the provisions of the
23 Budget Management Act of 1976 (Code of Alabama 1975, Sections
24 41-19-1 et seq.), and shall be in the amounts hereinafter
25 specified.

26 (b) Amounts shown hereinunder the columns "Earmarked
27 Funds" and "Appropriation Total" are as set forth for the

1 purpose of establishing amounts estimated to be available by
 2 programmatic area from sources other than those listed in
 3 subsection (a) of this Section 2, in order, upon consideration
 4 of such other funds so estimated to be available, to promote
 5 the accountability for an efficient use of funds available,
 6 and the same are hereby appropriated by the Legislature.
 7 Provided, however, that regardless of the ending date of any
 8 pay period which has been or may be established by the
 9 Legislature for the payment of salaries of state employees,
 10 the entire payment due shall be made from the fiscal year's
 11 appropriation in which the pay date falls.

 30 funding of summer schools or

 36 dents shall be defined as
 37 those students who score at
 38 level 1 or level 2 (not profi-
 39 cient/partially proficient) in
 40 reading or mathematics on the
 41 current state assessments.
 42 Further, local school faculty
 43 and the school principal shall
 44 make specific recommendations
 45 for students at the school to
 46 be included as participants in
 47 the at-risk program. At-risk
 48 funds may be expended for stu-
 49 dent programs to improve the
 50 efficiency and utilization of

14 cordance with the provisions of the Code of Alabama 1975, Sections 16-13-230 through
15 16-13-239, and all other laws and regulations of the State Board of Education relat-
16 ing to the expenditure of such funds. These funds shall be used to provide a minimum
17 school term of 180 full instructional days and for equitable educational opportuni-
18 ties in the public schools of the state. Foundation Program calculations for FY
19 2010-2011 are based on the funding divisors set forth below. The divisors listed
20 below shall not serve to prescribe pupil-teacher ratios.

 2 there is hereby appropriated from the Education Trust Fund the
 3 following amounts to be conditioned upon the availability of
 4 funds, the recommendation of the Director of Finance, and the
 5 approval of the Governor:

2 Section 6. The appropriations made herein to an
3 agency or entity are for the valid purposes and/or operation
4 and maintenance of that agency or entity. There shall be no
5 pass-through appropriation by that agency or entity at the
6 direction of any member of the legislative, executive or
7 judicial branch of government. The director of any agency or
8 entity that is directed by a member of the legislative,
9 executive or judicial branch of government to pass-through an
10 appropriation to another state or non-state entity shall
11 report such directive to the Governor, the Chairs of the House
12 Education Appropriations Committee and the Senate Finance and
13 Taxation-Education Committee. Nothing in this section is
14 intended to prohibit a legislator or any other person from
15 asking for or asking about the status of a project that falls
16 within the legal purpose or function of that agency.

17 Section 7. In addition to the appropriations herein
18 made, all gifts, grants, contributions, insurance proceeds or
19 entitlements, in excess of the amount carried in this act,
20 including grants by the Congress of the United States,
21 municipalities or counties, to any department, division,
22 board, bureau, commission, agency, institution, office or
23 officer of the State of Alabama are hereby appropriated and,
24 in the event the same are recurring, are reappropriated to
25 such department, division, board, bureau, commission, agency,

1 institution, office or officer to be used only for the purpose
2 or purposes for which the grant or contribution was or shall
3 be made. Further, all state, county, municipal and educational
4 entities are authorized to disburse such sums as deemed
5 necessary by mutual agreement between said entities and the
6 State of Alabama, Department of Examiners of Public Accounts
7 to partially defray the cost of auditing services performed by
8 said agency. All such sums are hereby appropriated and
9 reappropriated if necessary to the Department of Examiners of
10 Public Accounts for audit services, to be expended through the
11 fund established by Section 41-5-24, Code of Alabama 1975.

12 Section 8. The State Superintendent of Education
13 shall make requisitions to the State Comptroller in favor of
14 the proper beneficiary in accordance with the law and rules
15 and regulations governing the expenditure or disbursement of
16 any and all funds appropriated to the State Department of
17 Education and/or the State Board of Education in this act,
18 whereupon the Comptroller shall issue his warrant therefor.
19 All other appropriations in this act shall be paid after
20 proper requisitions are made to the State Comptroller in the
21 manner now provided by law.

22 Section 9. Nothing in this act shall be construed to
23 affect or repeal any law authorizing or permitting any
24 college, school or other education or eleemosynary institution
25 of the State to receive, collect or disburse any fees,
26 tuitions, charges, sales, endowments, trusts or income
27 therefrom, which are now or may hereafter be authorized to

1 receive, collect or disburse. The receiving college, school or
2 institution shall further maintain separate accounts for such
3 receipts or shall maintain a system of accounting which will
4 show a cash flow of such receipts received under the provision
5 of this appropriation.

6 Section 10. The appropriations made herein to the
7 departments, boards, offices, commissions, and agencies
8 include the amount necessary and said departments, boards,
9 offices, commissions, and agencies are hereby directed to make
10 the transfer of funds to the State Personnel Department in the
11 amounts enumerated in the general appropriations act for the
12 fiscal year ending September 30, 2011. All agencies and
13 institutions enumerated in this act that receive services from
14 other governmental agencies enumerated in this act or the
15 general appropriations act shall make full payment in a timely
16 manner (as determined by the Department of Finance) for such
17 services.

18 Section 11. All encumbered balances of a previous
19 fiscal year appropriation other than the exclusions authorized
20 by the Code of Alabama 1975, Section 41-4-93, shall lapse no
21 later than September 30 of the fiscal year immediately
22 following the fiscal year for which the appropriation was made
23 and shall revert to the credit of the Education Trust Fund or
24 earmarked fund from which the appropriation or appropriations
25 were made.

26 Section 12. Upon certification to the Director of
27 Finance by the State Attorney General that a federal court has

1 ordered the State of Alabama to pay claims, attorney fees, or
2 other costs relating to said court order, funds are hereby
3 appropriated to the affected department, board, bureau, or
4 commission in the amount necessary to satisfy that court
5 order. Such appropriations are in addition to any other
6 appropriation heretofore or hereafter made in this
7 appropriation act. Such appropriations are conditioned upon
8 the availability of funds and a determination by the Director
9 of Finance that other current appropriations are not available
10 for court-ordered payments.

11 Section 13. All state-mandated and state-funded
12 salary increases and fringe benefits for Child Nutrition
13 Program workers shall be fully-funded from the Foundation
14 Program appropriation in this act, and shall therefore be
15 subsequently fully-funded by all local boards of education
16 from funds provided in this act from Other Current Expense and
17 not from funds generated by the Child Nutrition Program unless
18 the local school system's Child Nutrition Program has in
19 excess of a three-month operating reserve. Before any funds
20 may be utilized by the local board of education to pay for
21 salary or fringe benefits, the State Department of Education
22 Child Nutrition Program Administrator shall conduct an
23 analysis of each local board of education's Child Nutrition
24 Program, and certify that the program meets the three-month
25 balance as of the end of the previous fiscal year and shall
26 therefore insure that the use of the funds in excess of a
27 three-month balance will not be detrimental to the local Child

1 Nutrition Program. The State Department of Education Child
2 Nutrition Program Administrator shall certify to the State
3 Superintendent of Education that funds utilized in excess of a
4 three-month balance as of the end of the previous fiscal year
5 are in excess of any funds contained in an approved corrective
6 plan submitted by the local school system's Child Nutrition
7 Program for expenditures at each applicable school site for
8 facilities, equipment, personnel, and/or salary schedule
9 adjustments. It is the intent that no employee shall suffer a
10 reduction of hours, benefits, compensation, or termination of
11 employment and that no local Child Nutrition Program services
12 shall be contracted out as a result of this section. It is
13 further the intent of the Legislature that the State
14 Department of Education shall help to develop a plan to
15 eliminate any financial deficiencies that may arise in a local
16 Child Nutrition Program as a result of this section, and that
17 disputes which may arise regarding corrective action plans are
18 to be resolved by the State Department of Education
19 consolidated monitoring teams. The State Department of
20 Education shall give an annual report to the Legislature, the
21 Chair of the House Education Appropriations Committee, the
22 Chair of the Senate Finance and Taxation-Education Committee,
23 and the Legislative Fiscal Officer one month prior to each
24 regular session of the Legislature on the impact of this
25 section on the local Child Nutrition Programs.

26 Section 14. For FY 2011, local boards of education
27 may exercise flexibility among line item expenditures, not to

1 exceed 20% in any line item and not to create a reduction of
2 earned teacher units and/or local board of education support
3 personnel.

4 Section 15. Any amounts that may become due and
5 payable of Public School and College Authority Swaptions are
6 hereby authorized to be paid in the same manner as other debt
7 service on Public School and College Authority bonds including
8 items such as court costs and attorney fees.

9 Section 16. Notwithstanding any other provisions of
10 this act or any other act, any amount from appropriations for
11 the fiscal year ending September 30, 2010 to the various state
12 agencies and institutions in this act which are unexpended and
13 reverted on September 30, 2010 are hereby reappropriated to
14 the respective offices for the fiscal year beginning October
15 1, 2010.

16 Section 17. The Department of Finance may charge
17 agencies and other recipients of federal stimulus funds for
18 the cost of administering the American Recovery and
19 Reinvestment Act of 2009 and the Jobs for Main Street Act, to
20 be paid by such agencies and recipients from federal stimulus
21 funds.

22 Section 18. If merit pay increases are reinstated
23 after December 31, 2010, current anniversary dates will be
24 maintained for all employees. Agencies are prohibited from
25 adjusting employee anniversary dates to obtain merit pay
26 increases at an earlier date.

1 Section 19. The appropriations made herein to the
2 departments, boards, offices, commissions and agencies include
3 the amounts necessary to pay the State Employee Health
4 Insurance Board (SEIB). The SEIB rate shall be \$805 per month
5 for each full-time employee for the fiscal year ending
6 September 30, 2011. The SEIB shall adjust the insurance
7 program wherever appropriate to maintain the aforementioned
8 fixed rate.

9 Section 20. If any section, paragraph, sentence,
10 clause, provision or portion of this act or all or any portion
11 of the appropriations herein made is held unconstitutional or
12 invalid, it shall not affect any other section, paragraph,
13 sentence, clause, provision or portion of this act or any
14 other appropriation or appropriations or portion thereof
15 hereby made not in and of itself unconstitutional or invalid.

16 Section 21. All laws or parts of laws, general,
17 special, private or local in conflict with or inconsistent
18 with the provisions of this act are hereby expressly repealed.

19 Section 22. This act shall become effective on
20 October 1, 2010.
