9 A BILL
10 TO BE ENTITLED
11 AN ACT

13 To establish the boundary lines of the Town of Pike
14 Road, Montgomery County, Alabama, so as to include and annex
15 within the corporate limits of said Town all territory
16 encompassed within the area and with the boundary lines shown
17 on the map attached, which accurately depicts all the
18 territory to be included within and annexed into the corporate
19 limits of the Town.

20 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

21 Section 1. The boundary lines of the Town of Pike
22 Road, Montgomery County, Alabama, are hereby established and
23 altered, rearranged or changed so as to include within the
24 corporate limits of the Town of Pike Road, all of the
25 territory in Montgomery County, shown on the attached plat or
26 map of such territory in yellow.

1 Section 2. A map showing the territory proposed to
2 be included within the corporate limits of the Town of Pike
3 Road effective with this act is on file in the Office of the
4 Judge of Probate in Montgomery County, Alabama, and such map
5 is open to the inspection of the public.

6 Section 3. Upon this act becoming effective, the
7 territory included within the boundary lines and corporate
8 limits of the Town of Pike Road shown on the attached plat or
9 map are established. The annexation or attempted annexation of
10 any other territory within Montgomery County by the Town of
11 Pike Road, which was in dispute in litigation between the Town
12 of Pike Road and the City of Montgomery, is hereby vacated and
13 such territory, including without limitation parcel nos.
14 09-06-23-02-000-002.000, 09-06-23-02-000-003.001, and
15 09-06-23-02-000-003.002, is hereby de-annexed from the Town of
16 Pike Road.

17 Section 4. This act was adopted by the Legislature
18 pursuant to its plenary power with respect to municipalities
19 and particularly with respect to the boundaries and
20 territories included within the corporate limits of
21 municipalities. The Legislature determines and finds that a
22 property description other than that contained on the plat or
23 map attached to this act and recorded in the Office of the
24 Judge of Probate of Montgomery County, Alabama for public
25 inspection is unnecessary to accomplish purposes of this act
26 to approve the boundaries and territories as found and ordered
27 by the Circuit Court of Montgomery County, Alabama in

1 settlement of the pending litigation relating to disputes over
2 boundaries and territories of the City of Montgomery and the
3 Town of Pike Road.

4 Section 5. This act shall become effective upon the
5 passage and approval by the Governor, or upon its otherwise
6 becoming law, and upon the passage and approval of a companion
7 act establishing the boundary lines and corporate limits of
8 the City of Montgomery, and an act relating to municipal
9 taxation which authorizes the levy and sharing of sales and
10 use tax in settlement of a dispute with regard to boundaries
11 or territory.
