8 SYNOPSIS: Currently, the fee for the issuance of a
9 "Helping Schools" license plate is \$20.

10 This bill would provide that an owner of a
11 motor vehicle who is a resident of Alabama may
12 elect to pay a fee of \$40 for the purchase of a
13 personalized license plate bearing the words
14 "Helping Schools".

17 TO BE ENTITLED
18 AN ACT

20 To amend Sections 32-6-300 and 32-6-301, Code of
21 Alabama 1975, relating to the fee for the issuance of a
22 "Helping Schools" license plate; to provide that an owner of a
23 motor vehicle who is a resident of Alabama may elect to pay a
24 fee of \$40 for the purchase of a personalized license plate
25 bearing the words "Helping Schools".

26 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1 Section 1. Sections 32-6-300 and 32-6-301, Code of
2 Alabama 1975, are amended to read as follows:

3 "§32-6-300.

4 "(a) (1) Owners of all motor vehicles who are
5 residents of Alabama, upon application to the judge of probate
6 or commissioner of licenses, complying with the state motor
7 vehicle laws relating to registration and licensing of motor
8 vehicles and payment of the regular license fee for plates as
9 provided by law for the motor vehicle, and the payment of an
10 additional annual fee of twenty dollars (\$20), shall be issued
11 license plates which shall bear the words "Helping Schools."

12 "(2) Each owner of a motor vehicle who is a resident
13 of Alabama shall pay an annual fee of forty dollars (\$40) for
14 a personalized license plate bearing the words "Helping
15 Schools".

16 "(b) The plates shall be issued, printed, and
17 processed in the same manner as other personalized plates are
18 in this chapter. The plates shall be valid for five years and
19 shall be replaced at the end of the period with either
20 conventional plates or other personalized plates, or with new
21 "Helping Schools" plates. Payment of the required motor
22 vehicle license fees and taxes for the years during which a
23 new vehicle license plate is not issued shall be evidenced as
24 provided for in Section 32-6-63. The State Department of
25 Revenue shall design, or have designed, the "Helping Schools"
26 plates in compliance with all laws and regulations.

27 "§32-6-301.

1 "The net proceeds of the ~~twenty dollars (\$20)~~
2 additional revenues derived from sales of "Helping Schools"
3 plates as provided for in this division, less administrative
4 costs including the cost of production incurred by the
5 Department of Revenue in producing the plates, shall be
6 distributed by the judge of probate or license commissioner
7 to, as nearly as practicable, the school district designated
8 by the purchaser or if the purchaser does not make a
9 designation to the school district in which the funds were
10 generated to be used for the purchase of classroom supplies
11 and equipment in grades K through 12 of the public schools of
12 the school district."

13 Section 2. This act shall become effective on the
14 first day of the first month, following its passage and
15 approval by the Governor, or upon its otherwise becoming law.
