8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Education Trust Fund Advancement and  
10 Technology Fund to the Alabama Community College  
11 System in the amount of \$2,000,000 for the fiscal  
12 year ending September 30, 2018; to the public  
13 institutions of higher education in the amount of  
14 \$15,196,647; and to the Department of Education,  
15 the Board of Trustees of the Alabama Institute for  
16 Deaf and Blind, the Board of Youth Services School  
17 Districts, the Board of Directors of the Alabama  
18 School of Fine Arts, and the Board of Trustees of  
19 the Alabama School of Math and Science in the  
20 amount of \$41,190,275 for the fiscal year ending  
21 September 30, 2018.

23 A BILL  
24 TO BE ENTITLED  
25 AN ACT

1                   To make a supplemental appropriation from the  
2                   Education Trust Fund Advancement and Technology Fund to the  
3                   Alabama Community College System in the amount of \$2,000,000  
4                   for the fiscal year ending September 30, 2018, to the public  
5                   institutions of higher education in the amount of \$15,196,647,  
6                   and to the Department of Education, the Board of Trustees of  
7                   the Alabama Institute for Deaf and Blind, the Board of Youth  
8                   Services School Districts, the Board of Directors of the  
9                   Alabama School of Fine Arts, and the Board of Trustees of the  
10                  Alabama School of Math and Science in the amount of  
11                  \$41,190,275 for the fiscal year ending September 30, 2018.

12                  BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

13                         Section 1. In addition to all other appropriations  
14                         heretofore or hereafter made, there is hereby appropriated  
15                         \$2,000,000 from the Education Trust Fund Advancement and  
16                         Technology Fund to the Alabama Community College System for  
17                         the fiscal year ending September 30, 2018. This appropriation  
18                         shall be expended for equipment and/or deferred maintenance.

19                         Section 2. In addition to all other appropriations  
20                         heretofore or hereafter made, there is hereby appropriated a  
21                         total of \$15,196,647 from the Education Trust Fund Advancement  
22                         and Technology Fund to the public institutions of higher edu-  
23                         cation for the fiscal year ending September 30, 2018. This  
24                         appropriation shall be expended for: (1) repairs or deferred  
25                         maintenance of facilities for public education purposes in the  
26                         state; (2) insuring facilities; or (3) the acquisition or pur-

1 chase of education technology and equipment, or both. This  
2 appropriation shall be distributed as follows:

20 Section 3. In addition to all other appropriations  
21 heretofore or hereafter made, there is hereby appropriated a

1 total of \$41,190,275 from the Education Trust Fund Advancement  
2 and Technology Fund to the Department of Education, the Board  
3 of Trustees of the Alabama Institute for Deaf and Blind, the  
4 Board of Youth Services School Districts, the Board of  
5 Directors of the Alabama School of Fine Arts, and the Board of  
6 Trustees of the Alabama School of Math and Science for the  
7 fiscal year ending September 30, 2018. This appropriation  
8 shall be expended for: (1) repairs or deferred maintenance of  
9 facilities for public education purposes in the state; (2)  
10 classroom instructional support pursuant to 16-13-231(b)(2)c  
11 and Section 16-13-231.3; (3) insuring facilities; (4)  
12 transportation pursuant to Section 16-13-233; or (5) purchase  
13 of education technology and equipment or both.

14 Section 4. (a) The Department of Education shall  
15 allocate the funds appropriated herein to the local boards of  
16 education and entities as follows:

6 (b) Notwithstanding any other laws to the contrary,  
7 the funds appropriated to the Department of Education by  
8 subsection (a) of this section shall not be expended without  
9 prior approval of the State Superintendent of Education.

10 (c) The above appropriation for teacher professional  
11 development shall be used to provide technology tools and  
12 professional development services to classroom teachers in an  
13 effort to improve instruction and student learning gains.  
14 Funds shall be allocated to the Alabama Department of  
15 Education to support the Digital Tools for Teachers  
16 Initiative. The Department shall allocate funds through a  
17 grant for local education agencies that will serve an equal  
18 number of teachers per school system through the provision of a  
19 technology tools package. It is the intent of the legislature  
20 that the funds shall be expended only for a tools package that  
21 includes a laptop, wireless tablet, a projector and  
22 professional learning services. The Department shall make a  
23 determination as to which packages are approved for district  
24 purchases.

1                   The State Superintendent shall provide a report of  
2                   the initiative to the Chair of the Ways and Means Committee in  
3                   the House and the Chair of Finance and Tax in the Senate no  
4                   later than October 1, 2019.

5                   Section 5. This act shall become effective  
6                   immediately upon its passage and approval by the Governor, or  
7                   upon its otherwise becoming law.
