8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Education Trust Fund to the Department of  
10 Veterans' Affairs in the amount of \$4,294,859 for  
11 the fiscal year ending September 30, 2018; and  
12 makes a supplemental appropriation from the  
13 Education Trust Fund to the State Department of  
14 Education for the Alabama School of Cyber and  
15 Engineering in the amount of \$500,000 for the  
16 fiscal year ending September 30, 2018; and allows  
17 the Alabama Community College System to encumber  
18 unexpended Fiscal Year 2018 appropriations for use  
19 in Fiscal Year 2019.

21 A BILL

22 TO BE ENTITLED

23 AN ACT

25 To make a supplemental appropriation from the  
26 Education Trust Fund to the Department of Veterans' Affairs in  
27 the amount of \$4,294,859 for the fiscal year ending September

1 30, 2018; and to make a supplemental appropriation from the  
2 Education Trust Fund to the State Department of Education for  
3 the Alabama School of Cyber and Engineering in the amount of  
4 \$500,000 for the fiscal year ending September 30, 2018; and to  
5 allow the Alabama Community College System to encumber  
6 unexpended Fiscal Year 2018 appropriations for use in Fiscal  
7 Year 2019.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. In addition to all other appropriations  
10 heretofore or hereafter made, there is hereby appropriated  
11 \$4,294,859 from the Education Trust Fund to the Department of  
12 Veterans' Affairs for the fiscal year ending September 30,  
13 2018. This appropriation shall be expended for the Student  
14 Financial Aid Program.

15 Section 2. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$500,000 from the Education Trust Fund to the State Department  
18 of Education for the fiscal year ending September 30, 2018.  
19 This appropriation shall be expended for the Alabama School of  
20 Cyber and Engineering.

21 Section 3. Section 9 of Act 2017-335 is amended to  
22 read as follows:

23 "Section 9. All encumbered balances of a previous  
24 fiscal year appropriation other than the exclusions authorized  
25 by the Code of Alabama 1975, Section 41-4-93, shall lapse no  
26 later than September 30 of the fiscal year immediately  
27 following the fiscal year for which the appropriation was made

1 and shall revert to the credit of the Education Trust Fund or  
2 earmarked fund from which the appropriation or appropriations  
3 were made.

4 "Notwithstanding the foregoing, the Alabama  
5 Community College System may encumber any unexpended  
6 appropriations as of September 30, 2018 and direct those  
7 unexpended appropriations to the Alabama Community College  
8 System's FY 2018/2019 budget appropriations, provided such  
9 unexpended but encumbered funds are used solely for the  
10 purpose of the Alabama Community College System implementing  
11 an independent enterprise resource planning management system  
12 in conformity with its body corporate status."

13 Section 4. This act shall become effective  
14 immediately upon its passage and approval by the Governor, or  
15 upon its otherwise becoming law.
