24 intention may be expressly stated or implied and the person  
25 communicating the threat has the ability to carry out the  
26 threat.

3           A copy of the form shall be prominently posted and  
4 accessible on the website of each local board of education and  
5 school, shall be available at each school office, and shall be  
6 included in the student handbook that is distributed to each  
7 student at the beginning of each school year.

11           At the beginning of each school year, each school  
12 shall programmatically address the issue of bullying and  
13 school violence with faculty and students. The program shall  
14 include a discussion of available resources and shall  
15 encourage the reporting of incidents of bullying. Each school  
16 shall also periodically convene a committee of faculty and  
17 students to review and discuss the issue of bullying and make  
18 recommendations to school administrators regarding school  
19 climate, safety, and bullying. The local superintendent of  
20 education may report any recommendations to the local board  
21 for its consideration.
