11 To make a supplemental appropriation from the  
12 Education Trust Fund to the Alabama Institute for Deaf and  
13 Blind, Board of Trustees in the amount of \$3,500,000 for the  
14 fiscal year ending September 30, 2021; to make a supplemental  
15 appropriation from the Education Trust Fund to the Educational  
16 Television Commission in the amount of \$5,500,000 for the  
17 fiscal year ending September 30, 2021; to make a supplemental  
18 appropriation from the Education Trust Fund to the Marine  
19 Environmental Sciences Consortium in the amount of \$2,000,000  
20 for the fiscal year ending September 30, 2021; to make a  
21 supplemental appropriation from the Education Trust Fund to  
22 Tuskegee University in the amount of \$1,000,000 for the fiscal  
23 year ending September 30, 2021; to make a supplemental  
24 appropriation from the Education Trust Fund to Athens State  
25 University in the amount of \$880,000 for the fiscal year  
26 ending September 30, 2021; to make a supplemental  
27 appropriation from the Education Trust Fund to the University

1 of West Alabama in the amount of \$592,300 for the fiscal year  
2 ending September 30, 2021; to make a supplemental  
3 appropriation from the Education Trust Fund to the University  
4 of South Alabama in the amount of \$900,000 for the fiscal year  
5 ending September 30, 2021; to make a supplemental  
6 appropriation from the Education Trust Fund to University of  
7 North Alabama in the amount of \$175,000 for the fiscal year  
8 ending September 30, 2021; to make a supplemental  
9 appropriation from the Education Trust Fund to Alabama  
10 Community College System in the amount of \$545,718 for the  
11 fiscal year ending September 30, 2021; to make a supplemental  
12 appropriation from the Education Trust Fund to the Department  
13 of Education in the amount of \$51,750,000 for the fiscal year  
14 ending September 30, 2021; to make a supplemental  
15 appropriation from the Education Trust Fund to the Commission  
16 on Higher Education in the amount of \$470,000 for the fiscal  
17 year ending September 30, 2021; to make a supplemental  
18 appropriation from the Education Trust Fund to the Historical  
19 Commission in the amount of \$275,000 for the fiscal year  
20 ending September 30, 2021; to make a supplemental  
21 appropriation from the Education Trust Fund to the Department  
22 of Archives and History in the amount of \$100,000 for the  
23 fiscal year ending September 30, 2021; to make a supplemental  
24 appropriation from the Education Trust Fund to the Department  
25 of Examiners of Public Accounts in the amount of \$574,000 for  
26 the fiscal year ending September 30, 2021; to make a  
27 supplemental appropriation from the Education Trust Fund to

1 the Education Trust Fund Advancement and Technology Fund in  
2 the amount of \$65,000,000 for the fiscal year ending September  
3 30, 2021; and to make a transfer from the Education Trust Fund  
4 to the Budget Stabilization Fund in the amount of \$75,000,000  
5 under certain conditions for the fiscal year ending September  
6 30, 2021.

7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

8 Section 1. In addition to all other appropriations  
9 heretofore or hereafter made, there is hereby appropriated  
10 \$3,500,000 from the Education Trust Fund to the Alabama  
11 Institute for Deaf and Blind, Board of Trustees for the fiscal  
12 year ending September 30, 2021. Of this appropriation,  
13 \$1,000,000 shall be expended for demolition and an  
14 environmental study of ANG Decatur Property; and \$2,500,000  
15 shall be expended for the Independent Living Center at AIDB  
16 Talladega.

17 Section 2. In addition to all other appropriations  
18 heretofore or hereafter made, there is hereby appropriated  
19 \$5,500,000 from the Education Trust Fund to the Educational  
20 Television Commission for the fiscal year ending September 30,  
21 2021 for nonrecurring expenditures, including but not limited  
22 to transmitters and fiber optic network.

23 Section 3. In addition to all other appropriations  
24 heretofore or hereafter made, there is hereby appropriated  
25 \$2,000,000 from the Education Trust Fund to the Marine  
26 Environmental Sciences Consortium for the fiscal year ending

1 September 30, 2021 to assist with recovery efforts from damage  
2 caused by Hurricane Sally.

3 Section 4. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$1,000,000 from the Education Trust Fund to Tuskegee  
6 University for the fiscal year ending September 30, 2021 for  
7 Armstrong Hall Laboratory improvements.

8 Section 5. In addition to all other appropriations  
9 heretofore or hereafter made, there is hereby appropriated  
10 \$880,000 from the Education Trust Fund to Athens State  
11 University, Board of Trustees for the fiscal year ending  
12 September 30, 2021 for one-time costs of HyFlex classrooms.

13 Section 6. In addition to all other appropriations  
14 heretofore or hereafter made, there is hereby appropriated  
15 \$592,300 from the Education Trust Fund to the University of  
16 West Alabama, Board of Trustees for the fiscal year ending  
17 September 30, 2021 for a campus wide security system.

18 Section 7. In addition to all other appropriations  
19 heretofore or hereafter made, there is hereby appropriated  
20 \$900,000 from the Education Trust Fund to the University of  
21 South Alabama for the fiscal year ending September 30, 2021  
22 for the School of Marine and Environmental Sciences.

23 Section 8. In addition to all other appropriations  
24 heretofore or hereafter made, there is hereby appropriated  
25 \$175,000 from the Education Trust Fund to the University of  
26 North Alabama for the fiscal year ending September 30, 2021  
27 for a workforce development pilot project.

1           Section 9. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$545,718 from the Education Trust Fund to the Alabama  
4 Community College System for the fiscal year ending September  
5 30, 2021. Of this appropriation, \$315,718 shall be expended  
6 for the Drake State Community Technical College NASA Frontiers  
7 Project, and \$230,000 shall be expended for the Wallace State  
8 Community College-Hanceville Winston County Learning Center  
9 project.

10           Section 10. In addition to all other appropriations  
11 heretofore or hereafter made, there is hereby appropriated  
12 \$51,750,000 from the Education Trust Fund to the State  
13 Department of Education for the fiscal year ending September  
14 30, 2021. Of this appropriation, \$50,000,000 shall be  
15 distributed to the TEAMS Fund established by House Bill  
16 537/Senate Bill 327 of the 2021 Regular Session of the  
17 Legislature or subsequent act of the Legislature for the  
18 purpose of implementing a new math and science teacher salary  
19 schedule; \$1,000,000 shall be expended for a marketing  
20 campaign for teachers; and \$750,000 shall be expended for the  
21 National Board for Certification of Teachers.

22           Section 11. In addition to all other appropriations  
23 heretofore or hereafter made, there is hereby appropriated  
24 \$470,000 from the Education Trust Fund to the Alabama  
25 Commission on Higher Education for the fiscal year ending  
26 September 30, 2021. Of this amount, \$270,000 shall be expended  
27 for the Best and Brightest STEM Pilot Program under the same

1 terms and conditions as Act 2020-204; and \$200,000 shall be  
2 expended for the Trails Foundation and allocated as follows:  
3 \$100,000 for the Singing River Trail and \$100,000 for the  
4 Pinhoti River Trail.

5 Section 12. In addition to all other appropriations  
6 heretofore or hereafter made, there is hereby appropriated  
7 \$275,000 from the Education Trust Fund to the Alabama  
8 Historical Commission for the fiscal year ending September 30,  
9 2021 for one-time expenses for Fort Toulouse.

10 Section 13. In addition to all other appropriations  
11 heretofore or hereafter made, there is hereby appropriated  
12 \$100,000 from the Education Trust Fund to the Alabama  
13 Department of Archives and History for the fiscal year ending  
14 September 30, 2021 for one-time expenses for the Civil Rights  
15 Voting Project.

16 Section 14. In addition to all other appropriations  
17 heretofore or hereafter made, there is hereby appropriated  
18 \$574,000 from the Education Trust Fund to the Department of  
19 Examiners of Public Accounts for the fiscal year ending  
20 September 30, 2021 for continuation of the evaluation and  
21 reorganization study of the State Department of Education.

22 Section 15. In addition to all other appropriations  
23 heretofore or hereafter made, there is hereby appropriated  
24 \$65,000,000 from the Education Trust Fund to the Education  
25 Trust Fund Advancement and Technology Fund for the fiscal year  
26 ending September 30, 2021 to be allocated in accordance with  
27 Section 29-9-4, Code of Alabama 1975.

1                   Section 16. In addition to all other provisions of  
2 this act, if the Finance Director certifies in September 2021  
3 that the ending balance in the Education Trust Fund for the  
4 fiscal year ending September 30, 2021 will exceed \$75,000,000,  
5 then \$75,000,000 shall be transferred to the Budget  
6 Stabilization Fund established by Section 29-9-4, Code of  
7 Alabama 1975.

8                   Section 17. This act shall become effective  
9 immediately upon its passage and approval by the Governor, or  
10 upon its otherwise becoming law.
